Terms of Use

Goosechase Adventures Inc. ("Goosechase") owns and operates the website located at goosechase.com ("Website") and the Goosechase application (the "App"). The Board of Governors of Missouri State University on behalf of Ozarks Public Television ("Ozarks Public Television" or "Sponsor"), (collectively, "we" or "us"), has created this *The American Ideal: A Gen Z Perspective* interactive experience with Goosechase .

These Terms of Use form a binding agreement ("Terms of Use" or "Terms") between Goosechase, Ozarks Public Television, and users of the Website, App, or service (discussed below), including without limitation registered users, users who upload any materials to the website, users who use services provided through the Website, users who download the App, and users who simply view the content on or available through the Website or App ("User" or "you").

By using the Website and/or the App you indicate your acceptance of these Terms of Use and [Goosechase's Privacy Policy](#). If you do not accept these Terms of Use, then do not use the App, Website, or any of its content or services. These Terms of Use may be changed or updated by Goosechase and/or Ozarks Public Television from time to time and we will post the revised Terms on the Website and App. Your continued use of the Website or App after we post the changed or updated Terms of Use shall signify your acknowledgement and acceptance of such revised Terms. We encourage you to visit the Website or App periodically to review these Terms of Use for any such changes. Any new features that may be added to the Website from time to time will be subject to these Terms of Use, unless stated otherwise.

1. The Service

The Goosechase service, provided through the Website and App, allows Users to create, join and complete missions designed by Ozarks Public Television for *America Through Our Eyes: An America @ 250 Goosechase Challenge* sweepstakes ("Service"). The Service includes missions comprised of various tasks which may include activities such as submitting photos or videos or answering questions in order to receive points or otherwise creating or contributing with other users ("Missions").

2. Age of Users and Parental/Guardian Consent

The Service is designed to be used by individuals who are eighteen (18) or older, or the age of majority in the jurisdiction of your residence, whichever is older ("Designated Age"). Individuals under the Designated Age, may only participate in the Service with the consent and supervision of their legal guardian. By participating in the Service, a User under the Designated Age represents and warrants that they have obtained their legal guardian's permission. By allowing a minor child to use the Service, the guardian agrees to be bound by these Terms and assume full responsibility for the child's activity and actions. Users under the Designated Age who are found to be participating without guardian consent will be deemed ineligible for participation and removed from the Service.

3. Disclaimer of Missions

ALL PARTICIPATION IN THE SERVICE, MISSIONS INCLUDING WITHOUT LIMITATION ANY CONTENT, TASKS, ACTIVITIES, EVENTS, LOCATIONS, LOCAL CONDITIONS AND CIRCUMSTANCES ARE THE SOLE RESPONSIBILITY OF USERS. This means that Users, and not Goosechase or Ozarks Public Television, are entirely responsible for their participation in any Mission and any consequences that may arise from that participation in that Mission.

How to Participate

To participate you must download the Goosechase App (the "App"). Downloading the App is free. After you download the App you can create an account or participate as a guest. Within the App you will be presented with missions. Each mission completed will be worth a certain number of points. Details of how to complete each mission and the number of points awarded will be stated within the App. Each mission can only be completed once. For multiple choice or trivia missions, if you select the wrong answer you will be provided an 'error' message and be permitted to correct your answer. Sponsor in its sole discretion shall determine if a mission is successfully completed or not. Missions will be released on the following dates:

- Friday, July 17 — 5:00 PM CST challenges

Dates and number of missions released are subject to change at any time. There will be a leaderboard presented with the App. The leaderboard represents the unverified totals and can be changed by the Sponsor at any time.

Each person may only have one account to participate. Any attempt by a participant more than once will void that participant's points and that participant will be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, illegible, or misdirected points.

Winner Determination:

On Monday, August 3, 2026 the Sponsor will determine the at least one participant that had the most points at the end of the day. The individual or individuals will win the prize for the challenge.
